with, and have personal knowledge of, the matters stated in this declaration and am competent to testify about them if called upon to do so.

2. Epiq was retained by counsel for the Deutsche Bank Defendants¹ to effectuate mailing of the Notice of Proposed Class Action Settlement and Proof of Claim and Release (together, the "Notice Packet") to certain members of the settlement class in connection with the proposed settlement with Crédit Agricole S.A. and Crédit Agricole CIB in the above-captioned case, as described more fully below.

MAILING OF THE NOTICE PACKET

3. On May 31, 2022, the Deutsche Bank Defendants' counsel provided Epiq with a list of 782 unique names and addresses of identified potential settlement class members.²

4. On or before July 13, 2022, pursuant to the Order entered by this Court on May 9, 2022, Epiq mailed copies of the Notice Packet by first class mail to each of the 782 potential settlement class members. This mailing was performed using the facilities of Epiq Systems Ltd., Epiq's affiliate located in the United Kingdom. A sample of the Notice Packet is attached hereto as Exhibit A.

5. None of the 782 Notice Packets that were mailed to potential settlement class members were sent to addresses with mailing restrictions or suspensions.
